Herd Health

Breeding Age Bulls

Breeding age bulls will have a minimum scrotal circumference of 32 cm and will have passed a breeding soundness evaluation (BSE) performed by a licensed veterinarian within 60 days of the sale date. Bulls will be in compliance with the Missouri State regulations regarding a negative Trichomoniasis status.

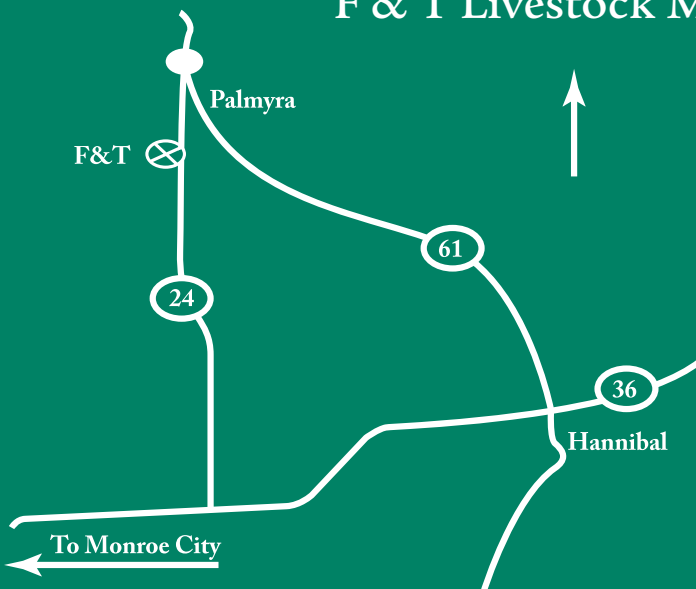
